## SOCIAL SECURITY ACT

### NOTICE (APPLICABLE FROM 6 APRIL 1975)

1. When this card was issued, the woman named was in one of these categories:-

- (a) women aged 65 or over;
- (b) women aged 60 or over who have retired, or are treated as having retired, for national insurance purposes;
- (c) married women and widows who elected not to pay National Insurance contributions.

2. Women in categories (a) and (b) will be liable to pay reduced-rate basic contributions when in Class 1 employment and have no liability to pay Class 2 contributions. A woman as in (c) whose election remains current may similarly be liable to pay reduced-rate basic contributions and not liable to pay Class 2 contributions without the need to make a fresh election.

3. A woman as in (c) who wishes to revoke her election or who remarries, becomes widowed or divorced, or has her marriage annulled, should tell her local Social Security office and return this card.
